2015 was a year of changes. We completed our new logo and look with the development of our new tagline and a renovation of our website. Sharon Radford, our long-time Volunteer Coordinator, retired after 16 years with New Horizons.

2015 was a year of financial gain. We received a gift of \$40,000 from a Blair couple to assist with the future purchase of a temporary shelter in Trempealeau County. Proceeds from our Annual Gala in March netted \$15,000 the largest I have seen in my tenure at New Horizons.

2015 was also a year of loss. Several of our team members left to move to better paying positions and a life in Onalaska was lost due to domestic abuse.

In 2016 we will continue to raise awareness, provide prevention and provide shelter advocacy for those fleeing abuse. We will not be able to do this without the support of our donors, volunteers and you. Please remember, together we can save lives.
